## ::NOTICE::

WCL has notified 5 Mine Specific Sources Vide Notice No. NGP/WCL/GM(M&S)/2021/839 Dated 25.02.2021, namely Sasti Exp. OC, Inder OC, Kamptee OC, Amalgated Inder-Kamptee OC and Adasa OC for which mine specific notified prices shall be effective wef 00:00 Hrs of 26.02.2021. Out of these 5 mines, Sasti Exp. OC, Inder OC & Kamptee OC are presently operative and Amalgated Inder-Kamptee OC & Adasa OC are upcoming mines.

Existing customers of Sasti Exp. OC, Inder OC & Kamptee OC under different schemes are being offered following one time dispensation:-

- a) <u>Linkage Auction</u>: The consumers of Linkage Auction shall be required to pay the revised notified price along with percentage of winning premium on revised price. In case revised price is not acceptable, consumer may opt for Exit option even if the Lock-in period of 2 years of FSA has not completed. The last date for applying for exit shall be 31.03.2021.
- b) <u>E-Auction</u>: Customers of different auction Schemes like, Spot E-auction, Special Forward E-Auction, Exclusive E-Auction etc will be required to pay the winning premium over and above the revised Notified Price or they may opt for refund of coal value along with EMD. Refund of EMD will be allowed to all such consumers who opt for refund.
- c) Other FSA:- Delivery Oder issued under any other scheme will attract revised Notified price from effective date or such consumer may opt for refund.

To continue lifting from above sources, consumers are requested to submit the differential payment on or before 08.03.2021. For Delivery Orders pending at Areas, differential payment should be deposited at Area. For Delivery orders pending to be issued from HQ and for Non Power Rakes which are pending for movement, differential payment should be deposited at HQ.
