Sub: Offer of coal to NRS Linkage Auction consumers of Rail Mode under change of mode of dispatch from Rail to Road against their pending rakes

The NRS Consumers of Linkage Auction of Rail Mode having more than one month's MSQ pending from the Primary Rail Source are being offered coal by Road Mode from following temporary sources against their pending rakes. The offer of coal from temporary source by Road Mode is being made in reference to scheme for Change of Mode from Rail to Road issued by CIL vide ref No. CIL/M&S/ NewPol(47252)/Change of Mode/273 Dated 05.05.2018.

The price payable for lifting of coal from above temporary sources by Road Mode shall be Mine Specific price for non Power Sector inclusive of commitment charge Plus % Premium of primary Rail source or highest % premium for the Temporary Road Source under any subsector during latest two (2) concluded tranches of NRS Linkage Auction, whichever is higher. The highest % premium of Pouni-II OCM under Tranche V Linkage Auction (Other subsector) is 92.52%, highest % premium of MKD-III OCM under Tranche V Linkage Auction (Other subsector) is 71.47%. whereas highest % premium of Neeljai OCM under Tranche V Linkage Auction (Other subsector) is 87.20%. NRS Consumers of Ballarpur Siding, Ghugus Old Siding, Ghugus New Siding, Wani Siding &Umrer Siding can apply for change of Mode from any of the sources or all of the sources. NRS Linkage Auction

consumers of Pandharpouni Siding are allowed to apply for sourcing coal only from Pouni-II OCM and / or from MKD-III only. NRS consumers shall clearly indicate number of pending rakes against their primary source which they want to change from Rail to road and name of desired temporary source by Road mode. Each NRS consumers should apply only upto maximum quantity allowed from each sources as indicated in table above.

If the sum total of quantities applied by all willing consumers from any of the source is more than offered quantity, the coal by Road Mode will be allocated to individual consumers in proportion to their applied quantity and in multiples of 4000 Tonne so that total allocation is limited to offered quantity from each source.

In view of above, the willing NRS Linkage Auction consumers may apply for seeking allotment of coal by Temporary Road Mode against their pending rakes. The last date for submission of application for change of mode will be 30th March'2023. Separate notice will be issued after 30th March'23 for notifying payment schedule and consumer wise allocation.
