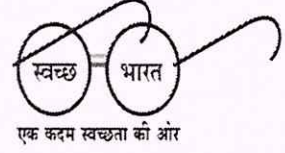

विषय: Customer-wise, source-wise allocation of coal for the CSA consumers of Dec'2020 in the 1st (Final) Round of allocation.

In response to our Notices No. No. NGP/WCL/M&S/RS/856 dt. 14.12.2020, applications made by 2 nos. of FSA LoA route consumers have been considered for allocation of coal for the month of Dec'2020. In terms of the procedure for allocation notified to the consumers vide our above cited notice, a total quantity of **12449Tes** has been allocated to these consumers in the 1st round of allocation against the applied quantity of **12449Tes**.

It is pertinent to mentioned that **M/s Ganga Papers India Ltd** didn't apply for the allocation of Dec'2020 against their offered/scheduled quantity of **768 Tes**. Hence, this is not considered for allocation.

The customer-wise, source-wise, size/ grade-wise allocations of coal finalised in this round is enclosed as **Statement 'A-1'**. The details of source-wise, grade-wise quantity offered, customer-wise quantity applied and quantity allocated along with the ratio applied for each customer for arriving at the allocation against the applied quantity are displayed herewith as **Statement 'B-1'**. The summary details of source-wise quantity offered to the consumers, quantity applied by the consumers and the quantity allocated from each source is enclosed as **Statement 'D'**.

As per the allocations made in the 1st round of allocation, the total quantity have been allocated to both the FSA LoA route consumers as applied by them. Hence this round may be treated as the final round of allocation for the month of Dec'2020.

As already informed, the last date for submission of payment against the allocations for the month of **Dec'2020** shall be **30.12.2020**. The consumers are urged to make payments only through RTGS/NEFT
