NOTICE TO THE CSA CONSUMERS FOR ALLOCATION OF COAL BY ROAD

Applications from CSA consumers (other than Power Utilities, IPPs and FSAs holders under Linkage Auction route) and from the eligible units in terms of the our Notice No. NGP/WCL/S&M/C-12(348)/1264 dated 06.02.2017 are invited for allocation of coal by road for the month of Feb'17 as per the procedure given below.

1. The source-wise, size / grade-wise quantity of coal available for allocation by road mode for Feb'17 is displayed herewith as **Annexure-1**.
2. The consumers are categorised into 10 Groups for the current month based on their entitled size/grade of coal for release, location of the mines, location of the consumers and availability of coal. The groups and the collieries and the size/ grade of coal for which consumers in each group are entitled for release of coal is displayed herewith as **Annexure-2**.
3. The consumers shall be required to make application and indicate the source-wise, grade-wise quantity of coal desired for allocation in the below mentioned format:

It should be ensured that the total quantity applied for does not exceed the applicable Entitled Quantity indicated in Annexure-2. In case the total applied quantity exceed the Entitled Quantity, the quantity applied in excess of the Entitled Quantity shall be deducted from the source from which maximum quantity is applied for. Similarly, the quantity applied from a source should not be more than the quantity offered from the source as per Annexure-1.

4. It should be ensured that application for allocation is made only from the source(s) mapped for the concerned group and the application from the source(s) which is not mapped for the consumer shall be rejected.

5. The applications are to be submitted at Road Sales Section, S&M Dept., WCL Hqr on or before 27.02.2017. The consumers can also send their applications through facsimile to Telephone No. 0712-2512977 and also by mail to ID: wclrdsales@gmail.com. The applications received beyond 27.02.2017 shall not be considered for allocation of coal in the 1st round.

6. In case the total applied quantity from a source is less than the offered quantity as displayed in Annexure-1, the entire applied quantity shall be allocated to the consumer. In case the total applied quantity is more than the offered quantity from a source, the allocation shall be prorated on the basis of the quantity applied by each consumer, subject to the other criteria mentioned herein.

7. The small consumers whose SQ is upto 350 tonnes shall be allocated 100% of the applied quantity from a source, provided the total applied quantity from that source by all such small consumers is within the offered quantity from the concerned source.

8. SQ of M/s MOIL Ltd., for its plants at Balaghat and Tumsar is pre-allocated from Sasti UG (Mix G6G6) and Umrer OC (G7G8 Mix) respectively. Also the SQ in respect of 6 no. of coke ovens entitled for WG-II Grade coal shall be pre-allocated from Tandsi Mine. The details are displayed herewith as '**Annexure-3**'.

9. The consumer-wise, source-wise quantity of coal allocated against the applications as per the procedure stated in this Notice and the balance quantity pending for allocation against the SQ shall be displayed in our website on 28.02.2017. The consumers shall be required to submit fresh application for 2nd round of allocation towards such unallocated quantity on or before 1.3.2017 as per format indicated in Para 3 above.

10. The source-wise quantity allocated to the consumers against the 2nd round of allocation as per the procedure stated in this Notice shall be displayed in our website on 1.3.2017. The date for submission of applications towards unallocated quantities if any, after the second round of allocation shall be 2.3.2017 and the details of allocation shall be displayed in our website on 2.3.2017.

11. The last date for submission of payment against the allocations for the month of Feb'17 shall be 10.03.2017. The consumers are urged to make payments only through RTGS / NEFT.

12. The offer for allocation of coal under this notice has been made in terms of the modalities informed to the consumers vide our earlier notice No.NGP/WCL/S&M/C-12(348)/824 dated 12.8.2016.

13. The offer for allocation of coal under this notice has been made in terms of the our earlier notice No.NGP/WCL/S&M/C-12(348)/1264 dated 06.02.2017 in respect of 30 nos of consumers having an MPQ of less than 4200 TPA. As already informed, WCL reserves the right to withdraw or modify the supply at anytime and any decision of WCL in respect of such supplies shall be final and binding to the consumers availing the same.

14. The release of coal against the allocation in terms of this notice shall also be subject to validity of the CSAs, verification of the monthly documents in case of the erstwhile non core sector consumers and as per eligibility of those existing consumers who had secured quantities in the Linkage Auction but execution of fresh FSA is pending.

15. The CSA holders through LoA route are advised to make application against the quantities notified for allocation under this notice only towards the domestic component of coal agreed under the under the CSAs.
