- 1.1. Ministry of Coal ("MoC") has *vide* its letter dated February 15, 2016 issued policy for "Auction of linkages of Non-Regulated sector" ("Policy").
- 1.2. In terms of the policy provisions, MoC vide letter dated 14.02.2022 & subsequent letter dated 20.05.2022 issued guideline for introduction of new subsector under NRS Linkage auction namely "Production of Syn-Gas leading to coal gasification".
- 1.3. Presently sixth tranche of NRS Linkage auction is being conducted by CIL through MSTC Ltd. ("Auction service Provider").

2. Eligibility Conditions

- 2.1. The coal consumers who have already taken coal linkage for Syn-Gas by participating in the linkage auctions under the sub-sectors of 'Sponge Iron' or in the 'Others' category; the gasification plants which are already set up and the coal block allocattees shall <u>not be entitled to participate</u> in the newly created sub-sector of 'Production of Syn-Gas leading to coal gasification'.
- 2.2. This window shall only be for new capacities that come up after the announcement of the sub-sector i.e. after 14.02.2022.
- 2.3. Should fulfil other provisions of NRS Linkage auction policy dated 15.02.2016
