Dear Sir,

With reference to the above, it is to inform that your firm M/s. Lifejet Ambulance Private Limited, Thane( L2 Bidder became L1) is established for acceptance of techno commercial L-1 bidder as per NIT, **tender evaluation clause no. 11 " G. In case the L1 bidder is rejected due to non-compliance of confirmatory documents the L-2 bidder will become L-1 bidder and confirmatory documents of this bidder shall be evaluated by TC and the process shall be followed as mentioned in clause no. A to F of NIT"** for the Hiring of 01 no. Ac ALS Ambulance (Force or Equivalent) Newly proposed for Area Hospital, for 24 hours basis, Avg. run 100 Km/day, 730 days (2 years), with 10 kmpl for Three drivers, Chandrapur Area WCL against the above GEM-tender.

Accordingly, uploaded offered supportive documents on GeM portal by your firm have been downloaded and technical scrutiny has been done by TC members and clarification was sought for shortfall document through GEM Portal system.

Your firm has responded against the clarification and submitted reply as under.

The clarification letter has been uploaded on GeM portal against the clarification and clearly mentioned in letter dated 24.07.2023 " **M/s. Lifejet Ambulances Private Limited, hereby inform you that due to company internal problem, our management team decided to withdraw the tender. Request you kindly do not consider our tender for technical evaluation and price evaluation.**" Hence, offer is rejected due to withdrawal of bid from the participation as per the NIT Clause.

The above statement is expressed that your firm have back out from the tender and attract penal action as per NIT condition as below.

**As per NIT Clause no.13 Tender evaluation: (I) For ECV less than 50 Lakhs :**

K. If L1 bidder backs out i.e. Techno commercially established L1 bidder), the EMD will be forfeited and the bidder will be debarred for minimum one (1) year from participating in tenders in CIL/Subsidiary.

**As per the clause no. 11 : Modification and withdrawal of bid**

Modification of the submitted bid shall be allowed online only before the deadline of submission of tender and the bidder may modify and resubmit the bid online as many times as he may wish. Bidders may withdraw their bids online within the end date of bid submission and their EMD will be refunded. However, if the bidder once withdraws his bid, he will not be able to resubmit the bid in that particular tender. For withdrawal of bid after the end date of bid submission, the bidder will have to make a request in writing to the Tender Inviting Authority. Withdrawal of bid may be allowed till issue of work order/LOA with the following provision of penal action:

1. The EMD will be forfeited and

2. **The bidder will be debarred for 1(One) year from participating in tenders in WCL.**

The Price-bid of all eligible bidders including this bidder will be opened and action will follow as under:

- i). If the bidder withdrawing his bid is other than L 1, the tender process shall go on.
- ii). **If the bidder withdrawing his bid is L-1, then re-tender will be done.**

Your firm has violated terms and conditions of NIT as mentioned above which was highly objectionable and leads to attract for imposition of penalty.

Inview of the above, following action is being taken by the management as per Clause no.17 of NIT

- a. The firm is debarred for 1(One) year from participating in tenders in WCL w.e.f 08.09.2023.
- b. Incident is raised as per GeM Portal incident management policy.
