Sub: - Revision of grade in the Annual Grade declaration for FY 2023-24

All the customers/bidders of Spot e-auction and CIL e-auction Scheme 2022 are hereby informed that vide notice no. WCL/HQ/QC/AGD23-24/1392 dt 30/31.03.2023 of GM (QC), WCL the declared grade of the mines has been revised. The bidders of Spot/CIL e-auction can avail the following dispensation:-

- 1. Notice to Customers drawing coal under Spot e-Auction

Sub: Revised Modalities in case of change in Declared Grade of coal post e-Auction

Kind attention is invited to our Notice No. NGP/WCL/M&S/RS/612 dated 31.03.2020, wherein the procedure for refund of coal value/EMD and/or release/dispatch of coal against booking of Spot e-Auction Scheme consequent to Annual Grade Deceleration of Grade for the year 2020-21 was notified. Now, the modalities for lifting of coal in case of both upward and downward revision of grades against booking of Spot e-Auction has been changed and is as given below:

In case there is a change in declared grade at the time of lifting, the bidder shall be required to pay the following amount:

(a) Notified price of Revised Grade

<u>plus</u>

(b) Percentage add on over notified price for arriving at Reserve Price at the time of Auction

plus

(c) Percentage premium over reserve price as per successful bid.

Or

(d) The original bid price whichever is higher

Interested consumers can lift the coal in case of upward revision of grade by paying additional difference amount and/or would lift the coal at bid price in case of downward revision of grade. However, a consent from the bidders is to be taken in all cases.
