विषय/ Sub: Deposition of differential payment by the bidders of CIL e-Auction Scheme 2022 conducted from Oct' 23

All the bidders of CIL e-auction held on 13.10.2023, 30.11.2023, 10.11.2023, 30.11.2023 & 15.12.2023 are hereby informed that vide notice no. NGP/WCL/M&S/Oprn./2023/1076 Dated 14.12.2023 of GM(M&S), WCL (copy enclosed as Annexure-I), the Surface Transportation Charges (STC) from pit head to loading point of coal for all existing lead distances has been revised w.e.f. 00:00 hrs of 25.12.2023. As per the said notice the differential amount due to STC revision is to be remitted on or before 03.01.2024 or the validity of the sales order whichever is earlier.

Further, vide notice no. WCL/M&S/2023/1118 Dated 23.12.2023 of GM (M&S), WCL (copy enclosed as Annexure-II), the differential amount due to STC revision is to be deposited through the CIL ICICI e-collection portal as per the Supplementary/ Revised Proforma Invoice (PI) on or before 03.01.2024 or the validity of the sales order whichever is earlier.

1. **For the Running Sales orders already released from HQ:** - The bidders are required to deposit the differential payment against the supplementary Proforma Invoice available in its CIL ICICI e-collection portal PI on or before 03.01.2024 or the validity of the sales order.
2. **For the Sales orders which are yet to be issued:** - The Proforma Invoice (PI) is to be revised as per the new rate. The payment for the coal value is to be deposited through CIL ICICI e-collection portal on or before 29.12.2023 and for the differential amount due to STC revision is to be remitted by 03.01.2024.

If the bidders fails to deposit the differential amount due to STC revision on or before 03.01.2024 or the validity of the sales order whichever is earlier then the proportionate Bid Security corresponding to the balance quantity shall be forfeited as per the terms and condition of CIL e-Auction Scheme 2022.

Sub: Revision of Surface Transportation Charges from pit-head to loading point of coal for all existing lead distance w.e.f. 00:00 hrs of 25.12.2023

This is for information of all customers/ bidders of WCL that the Surface Transportation Charges from pit head to loading point of coal for all existing lead distances effective from 00:00 hrs of 25.12.2023 will be as under:-

Distance Slab (Kms)	Revised STC Rate (Rs./Tonne)
0 to 3	46
3 to 10	80
10 to 20	134
Above 20	Actual + 10%

For the balance quantities to be delivered against the Delivery Orders as on 00:00 hrs of 25.12.2023, the customer would be required to pay the differential amount of STC.

Till such time the differential amount is not paid by the customers / bidders, the Areas shall withhold the delivery of the balance quantities against the respective Delivery Orders in proportion to the amount recoverable due to this revision.

The differential amount on account of the increase in the STC should be submitted at WCL HQ on or before 03.01.2024 for already issued DOs as well as DOs pending to be issued against the payments already received.

Appropriate action towards collection of STC shall also be taken by concerned sections at Head Quarter for dispatches by Rail mode.

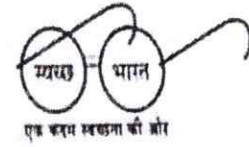

NOTICE TO ALL CONSUMERS DRAWING COAL BY ROAD MODE

Vide Notice no. NAG/WCL/M&S/Oprn./2023/1076 dt. 14.12.2023, the Surface Transportation Charges from Pit head loading point of coal for all existing lead distances is revised w.e.f. 00:00 Hours of 25.12.2023.

In this regard, it is advised that the differential payment towards the revision of surface transportation charges has to be remitted through CIL-ICICI e-collection Portal as being done for advance payment for all the running Sales Orders which are valid for lifting as well as the Sales Orders which are yet to be released by HQ. The detailed guidelines to be followed are as under:

Sales Orders which are yet to be released by WCL HQ:

For the Sales Orders which are yet to be issued, the concerned section (Road/Operation Section) shall issue fresh Proforma Invoice for payment of differential amount through the CIL-ICICI e-Collection Portal itself.

Sales Orders which are released by WCL HQ:

For the Sales Orders which are already released by WCL HQ and are valid for lifting beyond 24.12.2023, Area shall issue the Proforma Invoice for the differential amount to be collected for the unlifted quantity. Once the Proforma Invoice is generated by the Area after ensuring the completion of Delivery Document/Invoice generation till 24.12.2023, the Supplementary Proforma Invoice shall be available in the CIL-ICICI e-Collection portal for making payment. Consumers are advised to make payment for the differential amount against the respective Proforma Invoices separately. Once the payment is remitted, inform the concerned Area Sales Manager to check for the payment being tagged with the respective Sales Order and request for release of the withheld quantity.

It may kindly be noted that the differential amount towards this STC Revision is to be remitted within 03.01.2024.
