विषय/ Sub: Extension of last date for deposition of differential payment due to STC revision to 11.01.2024 for the bidders of CIL e-Auction Scheme 2022 due to STC revision

Vide notice no. WCL/M&S/2023/243 dt 23.12.2023 all the bidders of CIL e-auction held on 13.10.2023, 30.11.2023, 10.11.2023, 30.11.2023 & 15.12.2023 were informed that the last date for deposition of the differential payment due to the revision of the Surface Transportation Charges (STC) from pit head to loading point of coal for all existing lead distances w.e.f. 00:00 hrs of 25.12.2023, was 03.01.2024 for the running sales order at the area as well as for the sales order which are yet to be released.

Now, vide notice no. WCL/M&S/2024/1144 dated 04.01.2024 of GM(M&S), WCL (copy enclosed as Annexure-I), the last date of remitting the differential payment due to the STC revision has been extended till 11.01.2024 for the running sales orders at the area as well as yet to be issued sales orders. The differential amount due to STC revision is to be remitted on or before 11.01.2024 or the validity of the sales order whichever is earlier.

If the bidders fails to deposit the differential amount due to STC revision on or before 11.01.2024 or the validity of the sales order whichever is earlier then the proportionate Bid Security corresponding to the balance quantity shall be forfeited as per the terms and condition of CIL e-Auction Scheme 2022.

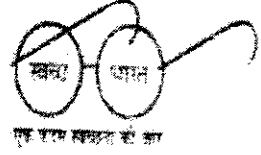

NOTICE TO ALL CONSUMERS DRAWING COAL BY ROAD MODE

Vide Notice no. NAG/WCL/M&S/Oprn./2023/1076 dt. 14.12.2023, the Surface Transportation Charges from Pit head loading point of coal for all existing lead distances had been revised w.e.f. 00:00 Hours of 25.12.2023. Further vide Notice No. WCL/M&S/2023/1119 dt. 23.12.2023 it had been advised to remit the differential payment towards the revision of Surface Transportation Charges (STC) through CIL-ICICI e-collection Portal itself as being done for advance payment for all the running Sales Orders which were/are valid for lifting.

It is noticed that few Supplementary Proforma Invoices weren't received by Customers within the due date i.e. 03.01.2024. Hence the last date for remitting the differential amount towards this STC Revision is extended till 11.01.2024 and Areas had been advised to generate Supplementary Invoices which were inadvertently not generated by Areas till now for remitting payment by customers through Bank Interface.

Customers who haven't made the differential payment towards revision of STC for the Sales Orders which are pending to be released from WCL HQ are also being given an opportunity to remit the differential payment within 11.01.2024 through the Bank Interface.
