

The Non-Power Consumers, who are not having valid LC with WCL are requested to make the advance payment as per provisions of FSA and as per dispensation given vide Notice No. WCL/NGP/M&S/Sect./573 dated 21/22.06.2018 (Annexure-I) and Notice No. WCL/NGP/M&S/Oprn/320 dated 10.06.2019 (Annexure-II). As per said notices, the advance payment shall be required to be made prior to planning of rake for movement and for intimation to railways. Non-Payment of coal value in advance shall lead to cancellation of allotted rakes for making way for movement of rakes next in seniority.

Consumers are requested to ensure submission of Railway freight as per extant Railway Rules, so that indented rakes can be moved without fail.

In eventuality of cancellation of rakes after allotment due to non-deposition of coal value / railway freight or cancellation by the consumer, the amount if any forfeited by railways on a/c of wagon registration charges shall be recovered from the consumer. Such cancellation of rakes shall be treated as failure on part of consumers.

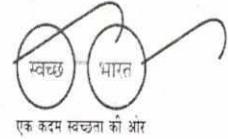

## NOTICE FOR NON POWR CONSUMERS TAKING COAL BY RAIL.

In view of backlog of rakes of the Non Power CSA consumers (including CPP/LOA and Linkage FSA), allotment of rakes for the year 2018-19 starting from offer month April,18 and onwards may be taken from Railways subject to the following conditions :

1. A request letter from the Non-Power CSA consumers (including CPP/LOA & Linkage Auction) to be submitted before 10 days of the last date of validity for indenting/seeking allotment of offered rakes for the month as per the Railway extent rules (Example : for the offered month of May'18, the last date of validity for indenting/seeking allotment is 31<sup>st</sup> July'18. Request letter is to be submitted by 21<sup>th</sup> July'18 (31 -10). However, for the offer month of April'18, request may be submitted by 25<sup>th</sup> June'18
2. Non Power FSA consumers (including CPP/LOA/ Linkage Auction) shall however be required to make fresh advance to ensure that the balance advance payment always remain equivalent to minimum one month's MSQ or 1 Rake ( if MSQ is less than 1 Rake=4000 Te.). The advance payment shall be required to be made prior to planning of the rake for movement and for intimation to the Railways. Non payment of coal value in advance shall lead to cancellation of allotted rakes for making way for movement of rakes next in seniority. Consumers are required to regularly visit ODR wise rake outstanding details in FOIS and ensure that coal value for senior most rake in seniority in a specific siding is paid in advance and no correspondence in this regard shall be made or entertained.
3. In the eventuality of cancellation of rakes after allotment due to non-deposition of coal value or cancellation by the consumer, Wagon Registration Fee as applicable shall be paid by the consumer.

4. In the eventuality of movement of allotted rakes by the Railway, pending deposition of coal value the consumers shall be liable to deposit the coal value with interest failing which same shall be realised from any sum due and/or by invoking BG available with WCL, in addition to cancellation of all rakes lying allotted on the date of default.
  
6. Consumers desirous for Indenting/allotment of their rakes pending deposition of coal value as offered to Railway for a specific month are required to submit their application strictly in the format enclosed as Anneure-A.


