Sub: Change of Mode of supply from Road to Rail pertaining to order booked under Special Forward e-Auction (SFEA)

In terms of directives issued from CIL vide ref No. CIL/M&S/1871 dated 23.04.2020 (Annexure-I) for change of mode of supply from Road to Rail under Special Forward e-Auction Scheme for Power Sector, the Special Forward E-auction consumers of Road mode desirous for taking supply of coal upon change of Mode from Road to Rail, are requested to submit their application, mentioning the quantity they are willing to take by Temporary Rail Mode, against the Month of April'20, May'20 & June'20.

- 1. Consumers may opt for change of Mode from Road to Rail for quantity in multiple of 4000 Tes, hence it is necessary for willing consumer that their sum total quantity against month of April'20, May'20 & June'20 should be 4000 Tes or more.
- 2. Transportation of coal from stock to siding(s) shall be arranged by the concerned area.
- 3. There shall not be any adjustment of grade/ quantity for availing supply under such dispensation, willing consumers has to submit an undertaking in this regards along with their application.
- 4. In case of change of mode of transport from Road to Rail in case of SFEA, the % premium chargeable shall be higher of the following:
 - a. i) % premium at which the bidder had secured the quantities by Road Mode from the original source OR ii) Highest % premium over the notified price under SFEA from temporary Rail Mode source during last 2 years i.e. 2018-19 & 2019-20
 - b. in case no coal had been booked from the Rail siding under special forward e-Auction during last 2 years i.e. 2018-19 & 2019-20, the % premium of original Road Source of the bidder shall be applicable for the supply of coal from temporary source i.e Rail Siding.
- 5. This dispensation is optional in nature.



On the basis of application received for change of mode within the stipulated date, allocation by Rail Mode against Months of April'20, May'20 & June'20 shall be made and displayed on the website of WCL. Further, this is to inform that once the allocation of change of mode from Road to Rail is displayed in WCL website, no further request of change of Siding or request for change of mode from Rail to Road shall be considered.

The application for change of mode may be submitted to the HOD (M&S), Western Coalfields Ltd, Coal Estate, Nagpur along with undertaking.

Sub: Change of mode – Road to Rail pertaining to order booked under Special Forward e-Auction(SFEA)

CIL Board in its 402nd meeting held on 16.04.2020 has ratified the temporary dispensation for change of mode from Road to Rail pertaining to the order booked under Special Forward e-Auction Scheme, subject to the following conditions:

- The temporary dispensation shall be allowed for the period of exigency initially for three months i.e. April to June'2020 and after review with CIL for another three months, if required.
- Transportation of coal from Stock to Siding(s) is being arranged by the concerned Area of the Subsidiary
- Coal Company shall have to notify such dispensation so that similarly placed consumers willing to avail such dispensation may also request against such change of mode.
- There shall not be any adjustment of grade/quantity for availing supply under such dispensation. An undertaking shall be taken from the willing consumer by Coal Company in this regard.
- The Coal Company shall ensure that such dispensation will not entail any adverse financial implication.
- The modality for calculation of premium payable by the Bidders for the change of mode from Road to Rail in terms of the said dispensation shall be as below:
- In case of change of mode of transport from Road to Rail in case of Special Forward e-Auction (SFEA), the %premium chargeable shall be higher of the following:
 - i) % premium at which the Bidder had secured the quantities by Road mode from the original source.
 - ii) highest %premium over the notified price under SFEA from the temporary Rail mode source during the last 2 years i.e.2018-19 and 2019-20.

In case no coal had been booked from the Rail siding under Special Forward e-Auction Scheme during the last 2 years i.e., 2018-19 and 2919-20, the %premium of original Road source of the Bidder shall be applicable for supply of coal from temporary source i.e. Rail siding.

The dispensation shall be operation in nature

It is being advised to Coal companies that the above modality for change of mode from Road to Rail for SFEA is to be notified in their respective website so that willing consumers can request to them for availing such dispensation further to which coal companies shall send their proposal with recommendation to CIL for consideration.
