



The customers desiring to use the procured sand only for self-consumption and seeking to avail exemption from payment of TCS are requested to register with this office with the destination to be mentioned in the **Advance Receipt Voucher cum Sale Order**, along with Form No. 27C which shall be valid for the entire financial year.

The Buyer has to conform with the following terms & conditions:

1. Advance Receipt voucher cum Sale Order for the corresponding quantity of sand will be issued by this office, upon confirmation of the payment received at this end, at the prevailing rate, as detailed above.
2. WCL will issue Tax invoice in name of the Buyer if, they have name, address and GSTIN no. or Unique Identification Number.
3. The responsibility of quantity and quality of the segregated sand as per Indian Standards 383 (IS 383) shall be binding on Nagpur Area, WCL, only up to the Point of Supply located within the premises of WCL.

4. The buyer shall ensure Road worthiness of the vehicles as per RTO norms and provide GPS enabled vehicles and comply with other statutory obligations as applicable for sand transportation.
5. The buyer will submit the list of vehicles registration number intended to be deployed for sand transportation to the Office of Sub-Area Manager Gondagaon and there upon shall be issued with the letter for lifting of sand for the allowed vehicles only . The copy of valid papers of Road worthiness of the vehicles deployed has to be submitted by the buyer in the unit viz, Gondagaon from which sand is intended to be transported.
6. The buyer or his representative shall be present for one time measurement of carrying body/dala of the vehicles by the unit during its first deployment and the measurement paper is to be signed by both the parties (WCL & Buyer) and records will be maintained at respective units.
7. The measurement of sand shall be carried out as per prevalent practice of WCL only.
8. The daily rate of sand lifting shall be at the discretion of respective unit
9. The supply of sand will be executed between 6.00 AM to 6.00 PM only on working days.

The Buyer has to submit an application to this office (in the prescribed format as **Annexure A**) for securing **Advance Receipt Voucher cum Sale Order** along with the copy of Sale Intimation Letter and Bank certificate (as a proof of submission of remaining payment).
