<u>CRITERIA FOR APPOINTMENT OF AUDIT FIRMS</u> FOR SALARY & WAGE AUDIT IN WESTERN COALFIELDS LTD., NAGPUR.:

The above subject was discussed in 288th Meeting of Functional Directors of Western Coalfields Limited held on 8-12-2004.

FDs agreed that the criteria for appointment of Salaries & Wages Auditors as recommended by the Committee and brought out in the agenda note, may be followed for appointment of Salaries & Wages Auditors.

The details of the Criteria is given below:-

Firms which have done the wages audit for three consecutive years may not be considered for subsequent three years.

Firms which have done wages audit for one or two years should be considered for reappointment for a further term, if the accepted recovery in one term against salaries & Wages audited by them is at least twice the fees paid to them.

Initial appointment based on the criteria drawn up will be for one year. Thereafter, the appointment for the second and third years will be subject to the firms fulfilling the criteria of reappointment i.e. the accepted recovery in each term against salary and wages should be at least two times of the fees paid to them. Maximum consecutive audit period normally be for three years.

If a firm has been allotted any other type of audit i.e. Stores Verification and reconciliation, Internal audit etc, it will be not considered for appointment for wage audit for that year. Therefore, a firm can be considered for appointment only for one type of audit of a particular year.

As per our past experience it was observed that Chartered / Cost Accountants with proprietary status have performed very well and have given direct attention to the work in view of which the Company was able to get the benefit of substantial recovery.

If left only to the bench marks as stated earlier we may loose the services of such professionals / Hence a minimum of three allotments be kept for proprietors practicing in individual names out of a total of 16 allotments.

Also in exceptional circumstances management reserves the right to allot work up to 15% of the total allotment, subject to the firms fulfilling the requisite parameters.

Audit fees:

WCL is paying a Wage Audit fee @ Rs.1.75 per employee per month i.e. Rs.21/- per employee per year. Boarding & Lodging is provided free by WCL in their Guest House. No TA DA will be paid extra.

<u>CRITERIA FOR APPOINTMENT OF AUDITORS FOR</u> PHYSICAL VERIFICATION OF STORES AS ON 31-3-2007.

The above subject was discussed in 295th meeting of Functional Directors of Western Coalfields Limited held on 23-03-2005. FDs agreed to the criteria / norms recommended by a Committee for appointment of Auditors for Stores Audit. The details are given below:-

- 1. Firms which have done the Stores audit for Three consecutive years, may not be considered for subsequent Three years.
- 2. If a firm has been allotted any other type of audit i.e. Wages audit, P&M audit, Internal Audit, will not be considered for appointment for Store audit for that year. Therefore a firm can be considered for appointment only for one type of audit for a particular year.
- 3. Management reserves the right to allot 35% quota.
- 4. In order to encourage the members of The Cost Institute, at least two Cost Accounting Firms should be considered for allotment of work of Physical Verification of Stores.
- 5. Secondly to give encouragement to New Proprietary Firms / Partnership firms which have recently started practice i.e. since last 10 years and firms having maximum 4 partners are to be preferred as monetary involvement in terms of fees is much less.
- 6. Firms which have done store audit for one or two years may be considered for reappointment for a further term limiting it to 3 years (including the years already done) if their performance is satisfactory & if they fulfill the criteria.
