### NOTICE

FSA has been executed with consumers of linkage auction for non-regulated sector. The following options available to such consumers in terms of FSA provisions, for which the consumers has been informed vide notice No. NGP/WCL/S&M/RS/620 dated: 02.11.2016, issued by General Manager (S&M), WCL, HQ, Nagpur.

1. Those FSA holder who wish to avail supplies only against third-party sampling may choose to wait till it is implemented. WCL may not be liable for any delay on this account under this option.
2. In a interim measure, FSA holders may choose the option for joint sampling and analysis by seller.
3. As an interim measure, FSA holders may avail supplies on declared grade basis without sampling.

Third party sampling by CIMFR or CIMFR appointed agency or Independent third party agency (NABL) ( list already provided by CIL) is yet to commence for which reference has been made by WCL to CIMFR & CIL. As an interim arrangement those consumers desiring to avail joint sampling at loading point may give their concern and sign side agreement with WCL , QC, Department. The modalities for joint sampling is given below;

1. Total quantity secured by the consumers will be covered under the joint sampling at loading end as per the relevant clauses of BIS / FSA.
2. Sample collection, preparation and analysis at loading end shall be carried out by seller in presence of purchaser as per relevant clauses of BIS (IS 436 Part I / Section - I 1964, IS 1350 Part 1-1984 and IS 1350 Part II-1970) / existing FSA.
3. All tools and tackles, plastic bags, sealing compound and other items required for collection, preparation, storage and analysis of the sample shall be provided by the seller. The manpower engaged in sampling will be provided by seller.
4. Final laboratory sample shall be divided into two parts ( Part I and Part II) duly signed and sealed by both seller & purchaser. Part I shall be analyzed jointly at loading point for Moisture, Ash and GCV on Equilibrated condition basis (i.e 60 % RH & 40°C Temperature). The analysis results shall be applicable for all the commercial purposes.
5. In case the seller or purchaser is not satisfied with the Part I analysis results, the purchaser / seller has the liberty to raise dispute within 15 days from the date of receipt of analysis results. Seller will arrange to send Part II portion at Central Coal Testing & Research Laboratory ( CCTRL- NABL Accredited) or any Government Laboratory at Nagpur for analysis. The results shall be binding on both the parties (i.e Seller as well as Purchaser) for

all commercial purposes. The cost of the referee analysis will be borne by the party who raises the dispute, if they select the laboratory other than CCTRL.

6. Part II sample shall be retained in double sealed condition and kept in safe custody at loading point for 30 days from the date of collection. Part II sample will be destroyed after 30 days time from the date of collection, if parties fails to raise any dispute.
7. No separate sampling / analysis charges will be levied from the purchaser.
8. Results shall be communicated to the purchaser duly signed by both the parties and Proper analysis record shall be maintained at loading point.

The above said joint sampling work will be reviewed after two months. The interim arrangement for joint sampling shall be discontinued on commencement of the third party sampling CIMFR / Govt. Agency / Independent third-party agency.
