

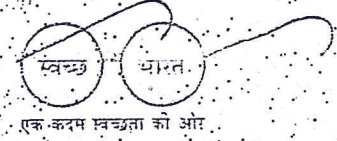

संदर्भ: Systemic Improvement against e-Open Tenders for procurement of goods.

महोदय,

During vigilance investigation of complaint against e-Open Tender floated by WCL for procurement of goods, following Systemic Improvement measure has been suggested by Vigilance Department, WCL which has been duly agreed by CMD, WCL.

As per the case history it has been noted that Performance Bank Guarantee has been accepted from OEM as per option given by bidder (Offer was submitted by the authorised dealer of manufacturer). As per NIT bidder was required to submit the PBG. The PBG was accepted as per prevalent practice because offer is submitted by authorised dealer on behalf of principal manufacturer only and guarantee/warranty is backed up by the manufacturer also in addition to the authorised dealer.

It has been advised by Vigilance Department, WCL that to avoid any post-tender ambiguity, the practice should be suitably incorporated in tender itself and should be made explicitly clear in bid itself. Further, it has been advised that the same may be suitably incorporated in Manual/Tender with due approval of competent authority.

Considering the above Systemic Improvement advised by Vigilance Department, WCL, you are requested to kindly consider, deliberate and make necessary provisions regarding acceptance of PBG from OEM (Principal manufacturer) also in the Clause No. 10.3.11 of Purchase Manual 2020. (In case offer is submitted by Authorised dealer/distributor on behalf of a Manufacturers), against tender specific Authorisation.
